A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE PHILIPPINE ASSOCIATION OF GENERAL SERVICES OFFICERS INC., (PAGSO INC.) TO BE TAKEN FROM THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS UNDER THE 2015 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR, OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.


WHEREAS, sometime in 2014, the Quezon City Government supported the hosting of the 9th PAGSO National Convention and pledged to grant financial assistance;


NOW, THEREFORE,


