MATIAS, TO BE DISTRIBUTED TO THE VARIOUS BARANGAYS OF THE 6<sup>TH</sup> LEGISLATIVE DISTRICT OF QUEZON CITY AND TO TRANSFER THE OWNERSHIP OF THE SAID VEHICLES, TO THE RECIPIENTS WITHOUT COST.

WHEREAS, the various barangays in the 6<sup>th</sup> District of Quezon City are in great need of vehicles that will allow them to bring their services closer to the people within their respective vicinities;

Matias, to be distributed to the various barangays of the 6<sup>th</sup> Legislative District of Quezon City, and to transfer the ownership thereof to the recipients without cost.
