*A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO ENTER INTO A CONTRACT/AGREEMENT WITH THE WINNING BIDDER FOR THE PURCHASE OF MEDICAL, DENTAL AND LABORATORY SUPPLIES AMOUNTING TO TWENTY MILLION NINE HUNDRED NINETY NINE THOUSAND NINE HUNDRED FIFTY PESOS AND EIGHTY FIVE CENTAVOS (PHP 20,999,950.85), TO BE DISTRIBUTED, OR TO BE USED BY, THE NOVALICHES DISTRICT HOSPITAL.*

*WHEREAS, Section 15, Article II of the 1987 Constitution mandates that the State shall protect and promote the right to health of the people and instill health consciousness among them;*

*WHEREAS, as stated in Section 455 (b) (1) (vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor, as the Chief Executive of the City Government, shall represent the city in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon the authority of the City Council, or pursuant to law and ordinance.*

*WHEREAS, the Purchase Request (PR) from the Hospital Director of the Novaliches District Hospital (NDH) amounting to Twenty Million Nine Hundred Ninety Nine Thousand Nine Hundred Fifty Pesos And Eighty Five Centavos (Php20,999,950.85) for the provision of medical, dental, and laboratory supplies to the NDH was granted;*


WHEREAS, on 25 February 2015, a Memorandum was issued by the City Mayor directing all heads of departments, offices and operating units to observe the requirement that all PRs with an approved budget for the contract (ABC) amounting to Ten Million Pesos (Php10,000,000.00) and above, must be accompanied by a resolution duly adopted by the City Council authorizing the Chief Executive to enter into such contract;

WHEREAS, pursuant to existing laws, rules and regulations, and in compliance with the aforementioned Memorandum from the City Mayor, this resolution is hereby made for the said purpose.


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Herbert M. Bautista, to enter into a contract/agreement with the winning bidder for the purchase of medical, dental and laboratory supplies amounting to Twenty Million Nine Hundred Ninety Nine Thousand Nine Hundred Fifty Pesos and Eighty Five Centavos (PHP20,999,950.85), to be distributed, or to be used by, the Novaliches District Hospital.


