A RESOLUTION AUTHORIZING THE QUEZON CITY GOVERNMENT, THROUGH THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO PURCHASE ONE (1) UNIT OF MOTOR VEHICLE INTENDED FOR MONITORING OF PROGRAMS AND PROJECTS OF THE OFFICE OF COUNCILOR LENA MARIE P. JUICO AMOUNTING TO ONE MILLION SIX HUNDRED THOUSAND PESOS (PHP1,600,000.00) TO BE CHARGED AGAINST THE OFFICE OF THE SAID CITY COUNCILOR.

Bautista, to purchase one (I) unit of motor vehicle intended for monitoring of programs and projects, of the Office of Councilor Lena Marie P. Juico, City Councilor, 1st District, Quezon City, amounting to One Million Six Hundred Thousand Pesos (Php1,600,000.00) to be charged against the funds of the Office of the City Councilor's Fund, Quezon City.
