A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO ACQUIRE THROUGH NEGOTIATED SALE THE PARCELS OF LAND IDENTIFIED AS LOTS 17 AND 18, BLOCK 37, (LRC) PSD-9707, COVERED BY TRANSFER CERTIFICATES OF TITLE (TCT) NUMBER RT-77536 (186998) AND RT-94342 (136694), REGISTERED UNDER THE NAME OF PAQUITO O. AZUELO AND RICARDO G. SANTOS, RESPECTIVELY, CONTAINING A GROSS AREA OF ONE THOUSAND EIGHT HUNDRED EIGHTY TWO (1,882) SQUARE METERS, MORE OR LESS, SITUATED AT MALIGAYA PARK SUBDIVISION, BARANGAY PASONG PUTIK, QUEZON CITY, PURPOSELY TO BE DEVELOPED INTO A SOCIALIZED HOUSING PROJECT FOR THE BENEFIT OF INFORMAL SETTLER FAMILIES (ISFs) IN QUEZON CITY.

WHEREAS, the Quezon City Government (LGU-QC), through its Task Force on Socialized Housing and Development of Blighted Areas (TF Housing), in its desire to provide greater opportunities to significant number of Quezon City informal settlers/residents to own an in-city affordable and decent housing, has been relentless in its efforts to expand its socialized housing projects;

WHEREAS, Mr. Paquito O. Azuelo and Mr. Ricardo G. Santos, registered owners of parcels of land located at Maligaya Park Subdivision, Barangay Pasong Putik, Quezon City, have expressed willingness to sell their property at a negotiated price, which properties are identified as Lots 17 and 18, Block 37, (LRC) Psd-9707, covered by TCT Nos. RT-77536 (186998) and RT-94342 (136694), respectively, containing a gross area of 1,882 square meters, more or less;

WHEREAS, the above-cited properties are vacant and considered suitable for socialized housing development;

WHEREAS, pursuant to Section 455 (b) (l) of Republic Act No 7160, otherwise known as the "Local Government Code of 1991", the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon the authority of the Sangguniang Panlungsod, or pursuant to law or ordinance.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Herbert M. Bautista, to acquire through negotiated sale the parcels of land identified as Lots 17 and 18, Block 37, (LRC) Psd-9707, covered by Transfer Certificates of Title (TCT) Number RT-77536 (186998) and RT-94342 (136694), respectively, registered under the name of Paquito O. Azuelo and Ricardo G. Santos, respectively, containing a gross area of One Thousand Eight Hundred Eighty Two (1,882) square meters, more or less, situated at Maligaya Park Subdivision, Barangay Pasong Putik, Quezon City, purposely to be developed into a socialized housing project for the benefit of Informal Settler Families (ISFs) in Quezon City.
