RESOLUTION NO. SP- **6730**, S-2016

A RESOLUTION AUTHORIZING THE QUEZON CITY GOVERNMENT, THROUGH THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO PURCHASE ONE (1) UNIT OF MOTOR VEHICLE INTENDED FOR MONITORING OF PROGRAMS AND PROJECTS OF THE QUEZON CITY GENDER AND DEVELOPMENT COUNCIL AMOUNTING TO ONE MILLION ONE HUNDRED THOUSAND PESOS (PHP1,100,000.00), TO BE CHARGED AGAINST THE AVAILABLE FUNDS OF THE CITY PLANNING AND DEVELOPMENT OFFICE - QUEZON CITY GENDER AND DEVELOPMENT (GAD) COUNCIL.

WHEREAS, the Quezon City Gender and Development (GAD) Council is requesting for the purchase of one (1) unit of motor vehicle intended for monitoring of programs and projects of the Quezon City Gender and Development;

WHEREAS, the specifications of the motor vehicle to be procured shall be as follows:

**SPECIFICATIONS:**

SUV, Diesel, A/T, 2.5 Liter, 4-Cylinder In-Line  
DOHC, 16 Valve, Direct Injection  
4 Stroke Common Rail Diesel Engine (D-4D),  
Turbocharged

**INCLUSION:** LTO REGISTRATION FOR 3 YRS

**WARRANTY:** Either repair or replace any supplied component part that is found defective in material or workmanship under normal use within a period of 36 months or 100,000 kilometers whichever comes first.


WHEREAS, pursuant to Administrative Order No. 1, amending Administrative Order No. 233, Series of 2008, the City Mayor, Honorable Herbert M. Bautista, has already sought permission and authorization from the DILG in his letter addressed to Mr. Juan Jovian E. Ingeniero, CESO IV, City Director of DILG, for the acquisition of the above-described motor vehicle amounting to One Million One Hundred Thousand Pesos (Php1,100,000.00), which amount shall be taken from the 2016 Annual Budget of the Quezon City Government under the City Council;

WHEREAS, Section 455 (b) (1) of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991", provides that the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon the authority of the Sangguniang Panlungsod, or pursuant to law or ordinance.


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the Quezon City Government, through the City Mayor, Honorable Herbert M. Bautista, to purchase one (1) unit of motor vehicle intended for monitoring of programs and projects of the Quezon City Gender and Development Council amounting to One Million One Hundred Thousand Pesos (Php1,100,000.00) to be charged against the available funds of the City Planning and Development Office - Quezon City Gender and Development (GAD) Council.


