BAUTISTA, TO DONATE VARIOUS EQUIPMENT TO ALL BARANGAY LOCAL GOVERNMENT UNITS, HEALTH CENTERS, DAY CARE CENTERS AND NON-GOVERNMENT ORGANIZATIONS IN DISTRICT VI, QUEZON CITY, AND TO TRANSFER THE OWNERSHIP OF SAID VARIOUS EQUIPMENT TO RECIPIENTS WITHOUT COST.

WHEREAS, it is the declared policy of the Quezon City Government to provide the necessary infrastructures/equipment to our barangays to ensure proper and efficient delivery of services to its constituents;

WHEREAS, in pursuit of the aforesaid policy, the Quezon City government represented herein by the City Mayor, Honorable Herbert M. Bautista, through the initiative of the Office of Councilor Diorella Maria G. Sotto-Antonio has procured various equipment such as Computer Sets, Window Type Air-conditioners, Tents and Hot-and-Cold Water Dispensers for the use of different institutions and non-government organizations (NGOs) like Day Care Centers, Barangay Health Centers, Office of Citizens Organization, among others;

WHEREAS, the said equipment will facilitate delivery of public service to the concerned sectors/stakeholders;

WHEREAS, as the primary source of funding for the said equipment, it is incumbent upon the City Government to undertake proper turn-over to the intended recipients in order to conform with the government auditing requirements;

WHEREAS, a Deed of Donation shall be executed with the recipients transferring the ownership of the said various equipment via donation;

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to donate, as it does hereby donate various equipment to all Barangay Local Government Units, Health Centers, Day Care Centers and Non-Government Organizations in District VI, Quezon City and to transfer the ownership of said various equipment to recipients without cost as part of the project of Councilor Diorella Maria G. Sotto-Antonio for the proper and efficient delivery of services to its constituents;

RESOLVED, FURTHER, that the ownership of the said various equipment be transferred to the various recipients through a Deed of Donation to be signed by the City Mayor, Honorable Herbert M. Bautista, the Office of Councilor Diorella Maria G. Sotto-Antonio as the main proponent, and the Office of the City General Services Department (CGSD) represented by Mr. Rolando P. Montiel.

RESOLVED, FINALLY, that copies of this Resolution along with the executed Deeds of Donation be given to the various recipients, the Office of the City Mayor, the City General Services Department and the Office of Councilor Diorella Maria G. Sotto-Antonio for reference purposes.
