*WHEREAS, petitioner Petron Corporation, a business entity duly registered under Philippine Laws, is applying for a Special Use Permit (SUP) to be used for the construction and operation of a gasoline refilling station to be located along Tandang Sora Avenue, Barangay Culiat, Quezon City;*

*WHEREAS, fuel stations are among the uses that require a Special Use Permit upon authorization from the Quezon City Council pursuant to the Quezon City Comprehensive Zoning Ordinance and its Implementing Rules and Regulations;*

*WHEREAS, Petron Corporation has complied with the necessary requirements for the issuance of a Special Use Permit as mandated by the aforementioned Quezon City Comprehensive Zoning Ordinance;*


*WHEREAS, the construction, installation and operation of a refilling gasoline station will provide employment and promote economic development in the City.*
