A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE QUEZON CITY PROSECUTOR'S LEAGUE IN THE AMOUNT OF SIX HUNDRED THOUSAND PESOS (PHP600,000.00) TO BE TAKEN FROM THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS UNDER THE 2016 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the grant of financial assistance to the Quezon City Prosecutor's League in the amount of Six Hundred Thousand Pesos (PHP600,000.00) to be taken from the appropriation for grants, subsidies and contributions under the 2016 Annual Budget of the Office of the City Mayor, or from any available funds of the City Treasury.
