A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, FOR THE PROCUREMENT OF SIX (6) MOTORCYCLE UNITS, TO ASSIST IN THE THE EFFECTIVE IMPLEMENTATION, OPERATION AND MONITORING OF THE SPECIAL TRAFFIC ACTION GROUP (STAG) — OFFICE OF THE CITY MAYOR, SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS.

WHEREAS, pursuant to Section 455 (b) (1) (vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, "the City Mayor shall represent the City in all business transactions and sign in its behalf all bonds, contracts, and obligation, and such other documents upon authority of the Sangguniang Panlungsod, or pursuant to law or ordinance";

WHEREAS, under Section 455 (4) of the Local Government Code of 1991, provides, "Ensure the delivery of basic services and the provision of adequate facilities as provided for under Section 17 of this Code and, in addition thereto, shall:

(i) Ensure that the construction and repair of roads and highways funded by the national government shall be, as far as practicable, carried out in a spatially contiguous manner and in coordination with the construction and repair of the roads and bridges of the city, xxx; and

(ii) Coordinate the implementation of technical services, including public works and infrastructure programs, rendered by national offices in the case of highly urbanized and independent component cities, and by national and provincial offices in the case of component cities.

WHEREAS, the Special Traffic Action Group (STAG) - Office of the Mayor, under the supervision of the Office of the City Administrator requests for the procurement of Six (6) Motorcycle Units, to be utilized and to assist in the implementation, operation and monitoring of its mandated functions;

WHEREAS, the motor vehicle requested shall have the following specifications, to wit:

Specifications:

"Engine type: liquid-cooled, 4-stroke parallel twin, DOHC8 valve; Displacement: 649cm; Fuel Supply: Digital fuel Ignition: bodies; Keihin throttle (038mmx2)iniection digital; Maximum Power: 71.1 hp rpm; Front Suspension: 41mm telescopic fork; Rear Suspension: offset laydown single-gas pressurized shock with 7 position adjustable pre-load; Frame Type: diamond high-tensil steel; LxWxH: 2,100mmx770mmx1,180mm; Wheelbase: 1,410mm; Seat Height: 805mm; Transmission: 6-speed return; Fuel Tank Capacity: 16liters; Front Tire Size: 120/70-17M/C (58W); Rear Tire Size: 160/60-17 M/C (69W); Breaks: Front: dual semi floating 300mm petal disc; Caliper: dual piston; Rear: single 220mm petal disc; Caliper: single piston; Dry Weight: 209 kg; Additional: with saddle bag (left & right); Front crushed guard & windshield; stand pole w/ revolving light and siren; with Registration and TPL insurance; Full Faced helmet; Sweatshirt and Plate holders"

WHEREAS, the City Council hereby authorizes Mayor Herbert M. Bautista, to grant the request of the Special Action Task Force (STAG) for the procurement of Six (6) Motorcycle Units, to assist in the effective implementation, operation and monitoring of its mandated functions, subject to existing laws, rules and regulations.
