A RESOLUTION AUTHORIZING THE QUEZON CITY GOVERNMENT, THROUGH THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO PURCHASE ONE (1) UNIT OF MOTOR VEHICLE INTENDED FOR MONITORING OF PROGRAMS AND PROJECTS OF THE OFFICE OF COUNCILOR VOLTAIRE GODOFREDO L. LIBAN III, AMOUNTING TO ONE MILLION THREE HUNDRED FOUR THOUSAND PESOS (PHP1,304,000.00) TO BE CHARGED AGAINST THE AVAILABLE FUNDS OF THE OFFICE THE SAID CITY COUNCILOR.

Inginiero, CESO IV, City Director of DILG, for the acquisition of the above-described motor vehicle amounting to One Million Three Hundred Four Thousand Pesos (Php 1,304,000.00), which amount shall be taken from the 2015 Annual Budget of the Quezon City Government under the City Council;








WHEREAS, Section 455 (b) (1) of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991", provides that the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to law or ordinance.


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the Quezon City Government, through the City Mayor, Honorable Herbert M. Bautista, to purchase one (1) unit of motor vehicle intended for monitoring of programs and projects of the Office of Councilor Voltaire Godofredo L. Liban III, amounting to One Million Three Hundred Four Thousand Pesos (Php1,304,000.00) to be charged against the available funds of the same office.
