WHEREAS, Viron Transportation Corporation, Inc. with principal office and garage at No. 1360 Blumentritt Street corner Maria Clara Street, Barangay San Isidro Labrador, Quezon City, is applying for a Special Use Permit for the operation of a bus terminal located at No. 697 EDSA, Barangay Immaculate Conception, District 4, Quezon City;

WHEREAS, in accordance with the provisions of Article VII, Section 2 and Article IX of Quezon City Ordinance No. SP-918, S-2000, and its Implementing Rules and Regulations, a Special Use Permit is required for this project;

WHEREAS, the petitioner has complied with all the prescribed requirements relative to the issuance of a Special Use Permit.
