*WHEREAS, the project is envisioned to provide free Wi-Fi Internet access in public places nationwide and will initially cover Class 3,4,5 and 6 municipalities, selected major cities and public places such as but not limited to public schools; libraries, hospitals, rural health units, police stations, state universities and colleges, public transport terminals and airports;*

*WHEREAS, the Department of the Interior and Local Government (DILG) in cooperation with the League of Cities of the Philippines (LCP) and the Department of Science and Technology (DOST), have agreed to cooperate and jointly commit in promoting community development through the use of information and communications technology for effective and efficient national and local governance in the country;*

*WHEREAS, the Local Government of Quezon City fully supports and commit itself to the implementation and success of national programs in as much as the same are intended to achieve development goals that will eventually benefit its constituents;*

*WHEREAS, in view thereof, there is a need to authorize Mayor Herbert M. Bautista, to enter in to and sign a Memorandum of Agreement on behalf of the Quezon City Government (QCG) with the Department of Science and Technology -Information and Communications Technology Office (DOST-ICTO) for the "Free Wi-Fi Access in Public Places" Project.*


