A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH ENGR. REYNALDO C. DAQUIGAN, REGISTERED OFLAND WHICH WILLPARCELOFOWNER. INTER-COMMUNITY - DRAINAGE THEAFFECTED/TRAVERSED BY IMPROVEMENT PROJECT BEING IMPLEMENTED BY THE QUEZON CITY GOVERNMENT ALONG THE BOUNDARY OF BISTEKVILLE-2 AND KALIGAYAHAN, INBARANGAYSUBDIVISIONS, CRUZVILLE NOVALICHES, QUEZON CITY.

WHEREAS, the construction of a cluster of about thirty-one (31) onestorey rowhouse in Block-I of Bistekville 2 Housing Project has affected the existing old main inter-community drainage line along the boundary of Bistekville-2 and Cruzville Subdivisions;

WHEREAS, in order to make the affected drainage line/system serviceable, there is a need for the Quezon City Government to implement drainage improvement project along the boundary of said subdivisions;

WHEREAS, the above-cited drainage improvement project has to traverse the property of Engr. Reynaldo Daquigan, identified as Lot 310-C-2-A, (LRC) Psd-123937, covered by Transfer Certificate of Title (TCT) No.  $\wedge$ -193270, located at Cruzville, Barangay Kaligayahan, Quezon City;

WHEREAS, in exchange for the grant of perpetual right-of-way for the aforementioned drainage improvement project, LGU-QC has offered Engr. Daquigan a house and lot in Bistekville-2 for free, which house and lot is specifically described as one-storey with loft rowhouse unit in Lot 9, Block 1, covered by TCT No. 004-2013002316, registered under the name of LGU-QC, containing a floor area of 27 square meters and lot area of 28 square meters, more or less;

WHEREAS, Engr. Daquigan has accepted the offer of LGU-QC, and agreed to enter into a Memorandum of Agreement, which shall contain the terms and conditions of the exchange;

WHEREAS, pursuant to Section 455 (b) (l) of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991", the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to law or ordinance.

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Herbert M. Bautista, to enter into a Memorandum of Agreement with Engr. Reynaldo C. Daquigan, registered owner of a parcel of land that will be affected/traversed by the inter-community drainage improvement project being implemented by the Quezon City Government along the boundary of Bistekville-2 and Cruzville Subdivisions, in Barangay Kaligayahan, Novaliches, Quezon City.
