BAUTISTA, TO ENTER INTO A MEMORANDUM OF AGREEMENT ON BEHALF OF THE LOCAL GOVERNMENT OF QUEZON CITY WITH THE QUEZON CITY PUBLIC SCHOOL TEACHERS ASSOCIATION AND THE ALLIANCE OF CONCERNED TEACHERS PHILIPPINES, INCORPORATED, FOR THE CONSTRUCTION OF A MULTI-PURPOSE BUILDING TO HOUSE THEIR OFFICES.

WHEREAS, the local government of Quezon City entered into a Memorandum of Agreement with the Quezon City Public School Teachers Association (hereafter, "the Association") and the Alliance of Concerned Teachers-Philippines Inc. (hereafter, the "Alliance") authorizing the construction of a multi-purpose building on an open space along Mines Street, near Mines Elementary School, Barangay Vasra, Quezon City, with an area of 385.25 square meters covered by Transfer Certificate of Title No. 262146 (RT-9611) registered in the name of the local government of Quezon City, to house the offices of both the Association and the Alliance;

WHEREAS, the said Memorandum of Agreement executed on 17 December 2003 was effective for a period of 10 years, renewable at the option of the local government of Ovezen City; y

WHEREAS, the multi-purpose building thus constructed served as the nerve-center of the Association and the Alliance and contributed to the development of their capabilities and the institutionalization of programs for the benefit of their members, namely public school teachers in Quezon City;

WHEREAS, the Association and the Alliance have proposed to renew and/or reinstate the aforesaid Memorandum of Agreement and the local government of Quezon City, through the Sangguniang Panlungsod, hereby accepts their proposal.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Herbert M. Bautista, to enter into a Memorandum of Agreement on behalf of the Local Government of Quezon City with the Quezon City Public School Teachers Association and the Alliance of Concerned Teachers Philippines, Inc. for the construction of a Multi-Purpose Building to house their offices.

RESOLVED, FURTHER, to ratify all things done for the purpose and which are necessary or incidental to give effect to this authority.
