*WHEREAS, since 1968, this hospital has contributed to the advancement of health care in Quezon City, offering a continuously growing array of health and hospital services;*

*WHEREAS, the Quezon City General Hospital, in fulfilling its primordial responsibility of bringing accessible health care of the highest standard to people of Quezon City, has been providing utmost quality medical care to patients who mostly are financially incapable;*

*WHEREAS, the Quezon City General Hospital is now experiencing an increase number of patients being treated, consulted and admitted for the past four years;*

*WHEREAS, in order to meet the demand of the increasing number of patients, Quezon City General Hospital has applied with the Department of Health for the increase of bed capacity from 250-bed to 300-bed;*

*WHEREAS, as required by the Department of Health in granting a Level III, tertiary training hospital accreditation, the Quezon City General Hospital should be authorized by the City Council through a Resolution for such increase in bed capacity.*
