RESOLUTION NO. SP. 6766 __, S-2016

A RESOLUTION URGING THE OFFICE OF THE CITY MAYOR, TO GRANT FINANCIAL ASSISTANCE IN THE AMOUNT OF ONE HUNDRED FIFTY THOUSAND PESOS (PHP150,000.00) TO PUNONG BARANGAY RONALD TAGLE OF BARANGAY CLARO OF THE 3RD DISTRICT OF QUEZON CITY, WHO WAS SERIOUSLY INJURED IN THE LINE OF DUTY WHILE DIRECTING THE TRAFFIC FLOW IN HIS BARANGAY, TO BE CHARGED AGAINST THE ACCOUNTS FOR DONATIONS, GRANTS AND SUBSIDIES UNDER THE OFFICE OF THE CITY MAYOR OR ANY AVAILABLE FUNDS OF THE CITY TREASURY.

WHEREAS, while in the line of duty, Punong Barangay Tagle was accidentally hit by a speeding Nissan Urvan with Plate Number ZTJ-297;

WHEREAS, as a result of the said incident, Punong Barangay Tagle suffered serious injuries which includes a broken arm (ulna and fibia), and confined at the De Los Santos Medical Center, Quezon City.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to urge, as it does hereby urge the Office of the City Mayor, to grant financial assistance in the amount of One Hundred Fifty Thousand Pesos (Php150,000.00) to Punong Barangay Ronald Tagle of Barangay Claro of the 3rd District of Quezon City, who was seriously injured in the line of duty while directing the traffic flow in his Barangay, to be charged against the accounts for donations, grants and subsidies under the Office of the City Mayor or any available funds of the City Treasury.
