A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO TWIN ACES INDUSTRIES, INC. LOCATED AT NO. 107 JUDGE JUAN LUNA STREET, SFDM, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS OF THE QUEZON CITY COMPREHENSIVE ZONING ORDINANCE NO. SP-1369, S-2004.

WHEREAS, the petitioner Twin Aces Industries, Inc. is the owner of a land located at No. 107 Judge Juan Luna St., SFDM, Quezon City and covered by Transfer Certificate of Title No. 12009;

WHEREAS, the company has been in the paint manufacturing for the last thirty (30) years and have been paying their taxes to the city religiously and employing a hundred of workforce and residents of Quezon City;

WHEREAS, substantial portion of the company's premises is primarily devoted for offices and warehouses which is permitted in the area, while a minimal portion thereof is being utilized for manufacturing;

WHEREAS, under the provisions of the Quezon City Comprehensive Zoning Ordinance No. SP-1369, S-2004, a Certificate of Exception is needed in order for Twin Aces Industries, Inc. to operate in the area;
