A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO DONATE ONE CCTV SYSTEM TO BARANGAY MARIANA, DISTRICT 4, QUEZON CITY AS PART OF THE QUEZON CITY GOVERNMENT'S CRIME PREVENTION PROGRAM WHICH WERE PURCHASED THROUGH THE FUNDS OF COUNCILOR JESSICA CASTELO DAZA AND AUTHORIZING THE TRANSFER OF OWNERSHIP OF THE SAID UNIT TO THE RECIPIENT WITHOUT COST TO THEM.

*WHEREAS, as part of the crime prevention and protection program of Quezon City one CCTV system was purchased through the funds of the Office of Councilor Jessica Castelo Daza;*

*WHEREAS, the CCTV system would be utilized as a first line of defense in the community in case of any criminal and fraudulent event struck the barangay;*

*WHEREAS, it is but proper to turn over the ownership of the CCTV system to the recipient so that these city-owned properties may be transferred without cost;*

*WHEREAS, a Deed of Donation will be executed with the recipient transferring the ownership of said CCTV system via donation, with the City assuming all fees and dues therein.*


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Herbert M. Bautista, to donate one CCTV system to Barangay Mariana in District Four Quezon City as part of the crime prevention program of the city, said equipment were purchased through the funds of the Office Councilor Jessica Castelo Daza to be distributed to thirty eight barangays (38) and authorizing the transfer of ownership of the said CCTV system to the recipient without cost to them


RESOLVED, FURTHER, that the ownership of said CCTV system be transferred to the recipient through a Deed of Donation to be signed by the City Mayor, Honorable Herbert M. Bautista, Councilor Jessica Castelo Daza and the City General Services Department (CGSD).

RESOLVED, FINALLY, that copies of this Resolution along with the Deed of Donation be given to the recipient barangay and the Office of Councilor Jessica Castelo Daza for future reference.
