WHEREAS, a Deed of Donation will be executed with the recipients transferring the ownership of said playground equipment via donation, with the city assuming all fees and dues therein.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorized the City Mayor, Honorable Herbert M. Bautista, to donate the playground equipment to recipient barangays in District Four Quezon City as part of promoting the advocacy of Quezon City as a child-friendly haven authorizing the transfer of ownership of the said equipment to the recipient without cost to them.

RESOLVED, FURTHER, that the ownership of said playground equipment be transferred to the recipient through a Deed of Donation to be signed by the City Mayor, Honorable Herbert M. Bautista, Councilor Jessica Castelo Daza and the City General Services Department (CGSD).

RESOLVED, FINALLY, that copies of this Resolution along with the Deed of Donation be given to the recipient barangays and the Office of Councilor Jessica Castelo Daza for future reference.
