A RESOLUTION DONATING TWENTY FOUR (24) UNITS OF MOTOR VEHICLE (PUJ TYPE) TO QUALIFIED SUBDIVISIONS LOCATED IN BARANGAY BATASAN HILLS, BARANGAY HOLY SPIRIT, BARANGAY BAGONG SILANGAN AND BARANGAY COMMONWEALTH, QUEZON CITY TO BE UTILIZED FOR THE PROMPT DELIVERY OF PUBLIC SERVICE WHICH WERE PURCHASED FROM THE FUNDS OF THE OFFICE OF COUNCILOR PRECIOUS HIPOLITO CASTELO.

WHEREAS, the City Government of Quezon City, through the Office of Councilor Precious Hipolito Castelo, shall donate twenty four (24) units of motor vehicle to qualified beneficiaries (subdivisions) in Barangay Batasan Hills, Barangay Bagong Silangan, Barangay Holy Spirit and Barangay Commonwealth;

WHEREAS, the said donation shall be accompanied by a Deed of Donation containing specifications of each motor vehicle subject of donation and the condition imposed in lieu of transfer; Res. No. SP- 6778, S-2016 Page -2- PR19CC-1412

WHEREAS, the twenty four (24) units of Motor Vehicle (PUJ type) were purchased using the funds of the Office of Councilor Precious Hipolito Castelo to be donated to qualified subdivisions in Barangay Batasan Hills, Barangay Holy Spirit, Barangay Bagong Silangan and Barangay Commonwealth, for the prompt delivery of public service within the subdivision subject of donation;

WHEREAS, the said donation is understood to be for community service purposes only and the use shall be exclusive only within the subdivision subject of donation and must not be used for personal, business, financial or profitable undertaking;

WHEREAS, it is established under Section 36 of Republic Act No. 7160, also known as the Local Government Code of 1991, "A local government unit may, through its local chief executive and with the concurrence of the sanggunian concerned, provide assistance, financial or otherwise, to such people's and non-governmental organizations for economic, socially-oriented, environmental, or cultural projects to be implemented within its territorial jurisdiction". Thus, such donation is in accordance with the said law.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to donate, as it does hereby donate twenty four (24) units of motor vehicle (PUJ type) to qualified subdivisions located in Barangay Batasan Hills, Barangay Holy Spirit, Barangay Bagong Silangan and Barangay Commonwealth to be utilized in the prompt delivery of public service which were purchase from the funds of the Office of Councilor Precious Hipolito Castelo.

RESOLVED, FURTHER, that the ownership of the said vehicles be transferred to the recipients through a Deed of Donation.
