A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO TWA, INCORPORATED FOR THE CONSTRUCTION AND OPERATION OF A FLYING V GASOLINE STATION LOCATED AT LOT 29 BLOCK 2 COMMONWEALTH AVENUE, BARANGAY FAIRVIEW, QUEZON CITY.

WHEREAS, petitioner TWA, Inc., a business entity duly registered under Philippine Laws, is applying for a Special Use Permit (SUP) to be used for the construction and operation of a Flying V Gasoline Station located at Lot No. 29 Block 2 Commonwealth Ave., Barangay Fairview, Quezon City;

WHEREAS, fuel stations are among the uses that require Special Use Permit upon authorization from the Quezon City Council pursuant to the Quezon City Comprehensive Zoning Ordinance; √




