RESOLUTION NO. SP- 6785, S-2016

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO NEGOTIATE AND ENTER INTO A CONTRACT WITH THE HEIRS OF MAXIMINA J. SANCHEZ FOR THE PURCHASE OF FIVE (5) PARCELS OF LAND BEING UTILIZED BY THE CITY GOVERNMENT FOR THE DEVELOPMENT AND REHABILITATION OF PAYATAS DUMPSITE.

WHEREAS, the Quezon City Government has taken possession of five (5) parcels of land owned by the late Maximina J. Sanchez with a total area of 3,588 square meters, which are being utilized for the development and rehabilitation of Payotas Dumpsite;

WHEREAS, the City Council, through Resolution No. SP-3453, Series of 2006, authorized the City Mayor, Honorable Feliciano R. Belmonte, Jr., to negotiate and enter into a contract to purchase the said parcels of land which were taken and being utilized by the city government for the rehabilitation and development of Payotas dumpsite, among other parcels of land. Unfortunately, Mayor Belmonte was unable to exercise such authority due to the expiration of his terms;
