WHEREAS, upon the strong representation of the League of Cities of the Philippines, the Department of Budget and Management included cities KALSADA program for the rehabilitation and improvement of city roads, on top of the allocation for Bottom Up Budgeting (BUB);

WHEREAS, the total allocations for KALSADA program of the Department of Budget and Management for all the cities of the country is Thirteen Billion Five Hundred Million Pesos (P13,500,000,000.00) to be implemented in the year 2017; ✓


NOW, THEREFORE,


