WHEREAS, these airconditioning units when installed in Lupon Offices would provide added convenience and increase productivity of the employees working therein;

WHEREAS, it is but proper to turn over the ownership of these equipment to the recipients so that these city-owned properties maybe transferred to them without cost;

WHEREAS, a Deed of Donation will be given to the beneficiaries transferring the ownership, encumbrances and dues of the said air conditioning units thereby authorizing them to appropriate funds for the maintenance of these units from their respective budgets.

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does, hereby authorize the City Mayor, Honorable Herbert M. Bautista, to enter into a Deed of Donation for the donation of Fifteen (15) city-owned airconditioning units purchased under the funds of the Office of Councilor Lena Marie P. Juico, to different barangays and day care centers within District I, this city, and authorizing the transfer of ownership of the said equipment to the recipients without cost.

RESOLVED, FURTHERMORE, that the donees be authorized to appropriate funds for the maintenance of these airconditioning units from their respective allocated budgets.

RESOLVED, FINALLY, that copies of this Resolution together with the Deed of Donation be given to the Fifteen (15) recipients, the Office of the City Mayor, the City General Services Department and the Office of Councilor Lena Marie P. Juico for future reference.
