RESOLUTION NO. SP- **6789**, S-2016

A RESOLUTION AUTHORIZING THE QUEZON CITY GOVERNMENT, THROUGH THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO PURCHASE SIX (6) UNITS OF ELECTRIC MOTOR VEHICLE (E-TRIKE) TO BE DONATED TO THE VARIOUS BARANGAYS OF DISTRICT VI, QUEZON CITY IN THE AMOUNT OF TWO MILLION THIRTEEN THOUSAND SIX HUNDRED PESOS (P2,013,600.00), CHARGEABLE AGAINST THE FUNDS OF THE OFFICE OF COUNCILOR CANDY A. MEDINA.

WHEREAS, the Office of Councilor Candy A. Medina is desiring to procure six (6) units of Electric Motor Vehicle (E-Trike) to be donated to the various barangays of District VI, Quezon City in order to hasten the delivery of public service, particularly in depressed areas with narrow streets;

WHEREAS, under Section 455 (b) (1) (vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the "city mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance";

WHEREAS, pursuant to the directive of the Department of the Interior and Local Government (DILG), the city government, through the City Mayor, must be given authority by the City Council prior to the procurement of the intended motor vehicle;

WHEREAS, the descriptions and warranties of the motor vehicles to be purchased by the Office of Councilor Candy A. Medina are hereunder enumerated:


NOW, THEREFORE,
