WHEREAS, pursuant to Section 455 (b) (1) (vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contract and obligations and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to law or ordinance;

WHEREAS, in the case of Hon. Gabriel Quisumbing v Hon. Gwendolyn F. Garcia (G.R No. 175527), the Supreme Court requires the City Council to give prior authorization to the City Mayor before any expenses/disbursement charged against a lump sum appropriation can be made;

WHEREAS, the Office of the City Mayor is requesting for an authorization to enter in a Contract/Agreement with the winning bidders for the purchase of Bituminous Prime Coat (Item 302) and Bituminous Concrete Surface Coarse (Item 310) for Asphalt,


Patching (FD) having an amount of Twenty Three Million Seven Hundred Seventy Five Thousand and Nine Hundred Ten Pesos (Php23,775,910.00) and above, specifically identified as follows:


