WHEREAS, the National Housing Authority (NHA) is a government corporation created and organized by virtue of Presidential Decree No. 757, dated 31 July 1975, as amended, with principal office and postal address at NHA Building, Elliptical Road, Diliman, Quezon City represented by its General Manager, Atty. Sinforoso R. Pagunsan;

WHEREAS, the National Housing Authority is the registered owner of several parcels of land, Block 19, Lot 5 classified as open space, situated in Barangay Project 6, District I, Quezon City covered by Transfer Certificate of Title No. 72861 issued by the Registry of Deeds of Quezon City;

WHEREAS, in compliance with the provisions of Presidential Decree No. 1216 dated 14 October 1979, the National Housing Authority, hereby donates and conveys in favor of the Quezon City Government, one (1) open space (LRC) Psd-57293 covered by TCT No. 72861 of the Registry of Deeds of Quezon City containing an area of One Thousand Forty Seven Square Meters and Eighty Square Decimeters (1,047.80), more or less;

WHEREAS, NHA Board Resolution No. 4115 dated May 27, 1999, the General Manager is authorized to donate to the local government concerned, all road lots and open spaces and other completed project components in the locality;

WHEREAS, the National Housing Authority hereby transfers, cedes and conveys by way of this Deed of Donation and Acceptance in favor of the Quezon City Government, all the rights, interest and title of the said parcel of land, free from all liens and encumbrances.
