RESOLUTION NO. SP- **6798**, S-2016

A RESOLUTION AMENDING RESOLUTION NO. SP-6575, SERIES OF 2015, "AUTHORIZING MAYOR HERBERT M. BAUTISTA, TO EXTEND FINANCIAL ASSISTANCE IN BEHALF OF THE QUEZON CITY GOVERNMENT IN THE AMOUNT OF THIRTY THREE MILLION FIVE HUNDRED FIFTY-SEVEN THOUSAND PESOS (PHP33,557,000.00) TO THE MUNICIPALITIES IN REGIONS II AND III OF NORTHERN LUZON SEVERELY AFFECTED BY TYPHOON LANDO (KOPPU), NAMELY: SAN MIGUEL, BULACAN; BALER, AURORA; AND BAMBANG, NUEVA VIZCAYA, TO BE TAKEN FROM THE QUEZON CITY DISASTER RISK REDUCTION AND MANAGEMENT FUND", REALLOCATING FUNDS AND INTENDED USE OF THE AMOUNT, SUBJECT TO EXISTING LAWS RULES AND REGULATIONS.

WHEREAS, on 01 December 2015, the City Council adopted Resolution No. SP-6575, Series of 2015, entitled: "A resolution authorizing Mayor Herbert M. Bautista, to extend financial assistance in behalf of the Quezon City Government in the amount of Thirty Three Million Five Hundred Fifty-Seven Thousand Pesos (Php33,557,000.00) to the municipalities in regions II and III of Northern Luzon severely affected by Typhoon Lando (KOPPU), Namely: San Miguel, Bulacan; Baler, Aurora; and Bambang, Nueva Vizcaya, to be taken from the Quezon City Disaster Risk Reduction and Management Fund";

WHEREAS, Resolution No. SP-6575, Series of 2015 authorized Mayor Herbert M. Bautista, to extend financial assistance to different municipalities that were greatly affected, devastated and destructed by Typhoon Lando (International Name: KOPPU);

WHEREAS, the financial assistance extended by the Quezon City Government (QCG), through Mayor Herbert M. Bautista, was focused on the rehabilitation and construction of various Infrastructure Projects that were destroyed by Typhoon Lando;

WHEREAS, pursuant to the MMDRRMC Resolution, the Quezon City Government, upon the recommendation of the Quezon City Disaster Risk Reduction and Management Council (QCDRRMC), included the proportioned amount extended based on the needs of the abovementioned LGUs, the said amount was divided as follows:

San Miguel, Bulacan	PhP28,111,000.00	Rehabilitation of farm to market roads
Baler, Aurora	PhP1,600,000.00	Agricultural assistance, such as, seeds & fertilizers, fishing boats for livelihood, infrastructure and rehabilitation
Bambang, Nueva Vizcaya	PhP3,846,000.00	Rehabilitation of irrigation system, provision of rescue equipment and other tools

WHEREAS, after a careful study and revisions to the original plan by the Quezon City Disaster Risk Reduction and Management Council (QCDRRMC), it recommended the re-appropriation of funds for the following infrastructure projects:
