RESOLUTION NO. SP- 6799 , S-2016

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO PROCURE ONE (1) UNIT OF MOTORIZED VEHICLE, TO BE DONATED AND UTILIZED AS A BARANGAY PATROL VEHICLE AND TO ASSIST IN THE THE EFFECTIVE IMPLEMENTATION, OPERATION AND MONITORING OF THE PROGRAMS AND/OR PROJECTS OF BARANGAY MASUSO, PANDI, BULACAN SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS.

WHEREAS, pursuant to Section 455 (b) (1) (vi) of Republic Act No. 7160 otherwise known as the Local Government Code of 1991, states that, "The City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance";

WHEREAS, under Section 455 (4) of the Local Government Code provides "Ensure the delivery of basic services and the provision of adequate facilities as provided for under Section 17 of this Code and, in addition thereto, shall:

- (i) Ensure that the construction and repair of roads and highways funded by the national government shall be, as far as practicable, carried out in a spatially contiguous manner and in coordination with the construction and repair of the roads and bridges of the city, xxx; and
- (ii) Coordinate the implementation of technical services, including public works and infrastructure programs, rendered by national offices in the case of highly urbanized and independent component cities, and by national and provincial offices in the case of component cities.

WHEREAS, a request was made by the Municipality of Pandi, Bulacan, specifically Barangay Masuso, to procure One (1) unit of motor vehicle to be utilized as a Barangay Patrol Vehicle and to assist in the implementation, operation and monitoring of the said barangay for their respective programs and/or projects;

WHEREAS, the motor vehicle requested shall have the following description, to wit:
