RESOLUTION NO. SP- 6800 , S-2016

A RESOLUTION AUTHORIZING THE QUEZON CITY GOVERNMENT, THROUGH MAYOR HERBERT M. BAUTISTA, TO GRANT FINANCIAL ASSISTANCE IN THE AMOUNT OF TWENTY MILLION FIVE HUNDRED SEVEN THOUSAND SIX HUNDRED THIRTY SEVEN PESOS (P20,507,637.00) TO THE MUNICIPALITY OF BULAN, SORSOGON FOR THE RESTORATION AND RECONSTRUCTION OF THE MUNICIPAL PUBLIC MARKET AND MUNICIPAL FISH PORT, DESTROYED BY TYPHOON NONA (MELOR), SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS.

WHEREAS, the City Government is empowered under Section 447 (1) (IV) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, to "Adopt measures to protect the inhabitants of the municipality from the harmful effects of man-made or natural disasters and calamities and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events";

WHEREAS, Typhoon "Nona" (International Name: Typhoon Melor) struck the Philippines and one of the most devastated was the Municipality of Bulan with Signal No. 3;

WHEREAS, the Municipality of Bulan, Sorsogon adopted Resolution No. 13, Series 2016, Respectfully requesting the Honorable Mayor Herbert Constantine M. Bautista, Quezon City, for financial assistance in the proposed rehabilitation of the Municipal Public Market and Municipal Fish Port greatly damaged by typhoon Nona on December 14, 2015;

WHEREAS, the Quezon City Government expressed its sympathy for the victims of Typhoon "Nona", most especially for the Municipality of Bulan, Province of Sorsogon;

WHEREAS, the Quezon City Government, through Mayor Herbert M. Bautista, is donaing the amount of Twenty Million Five Hundred Seven Thousand Six Hundred Thirty Seven Pesos (P20,507,637.00) to be taken from the General Fund, as financial assistance specifically for the purpose of the restoration and reconstruction of the Municipal Public Market and Municipal Fish Port of the Municipality of Bulan, Province of Sorsogon;

WHEREAS, Rule 18, Section 1 of the Implementing Rules and Regulations of Republic Act. No. 10121 (the Philippine Disaster Risk Reduction and Management Act of 2010) provides that upon the recommendation of the Local Disaster Risk Reduction and Management Council (LDRRMC) and approval of the Sanggunian concerned, the LDRRMC may transfer the said fund to support the disaster risk reduction of other LDRRMCs which are declared under state of calamity.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Herbert M. Bautista, in behalf of the Quezon City Government, to grant financial assistance in the amount of Twenty Million Five Hundred Seven Thousand Six Hundred Thirty Seven Pesos (P20,507,637.00) to the Municipality of Bulan, Sorsogon for the restoration and reconstruction of the Municipal Public Market and Municipal Fish Port, subject to existing Laws, Rules and Regulations.
