SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR).

WHEREAS, Alpha One Amusement and Recreation Corporation is a domestic corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines with principal office address at 26th Floor, West Tower, Philippine Stock Exchange Road, Ortigas Center, Ortigas Avenue, Pasig City;

WHEREAS, the Philippine Amusement and Gaming Corporation (PAGCOR) granted Alpha One Amusement and Recreation Corporation the authority to operate Electronic Bingo at the G/F and 2/F of Romero Building, No.1337 Balintawak Market, EDSA, Quezon City; ↓

WHEREAS, under the provisions of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Council, through a Resolution, may grant Special Permits or licenses;

WHEREAS, Alpha One Amusement and Recreation Corporation, through its representative, Mr. Alejandro P. Alonte, seeks to operate Electronic Bingo in Quezon City which necessarily need a Special Permit from the Quezon City Council.

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant a Special Permit to Alpha One Amusement and Recreation Corporation to operate an Electronic Bingo located at the G/F and 2/F of Romero Building, No. 1337 Balintawak Market, EDSA, Quezon City subject to the rules and regulations promulgated by the Philippine Amusement and Gaming Corporation (PAGCOR).

RESOLVED, FURTHER, that the authority to operate Electronic Bingo granted herein shall be subject to the following limitations:

- a. The holding of Electronic bingo shall be in accordance with the Rules and Regulations promulgated by PAGCOR;
- b. The operation of Electronic bingo shall not include the playing of games not related to or other than bingo;
- c. The operator is enjoined to prohibit individuals below eighteen (18) years of age from playing in the above-mentioned games.

RESOLVED, FURTHERMORE, that Alpha One Amusement and Recreation Corporation shall remit a franchise fee of three percent (3%) of the gross sales of herein grantee, which shall be made payable yearly to the City Treasurer during the lifetime of this measure.
