RESOLUTION NO. SP. 6810 , S-2016

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO SIGN AND ACCEPT THE DEED OF DONATION AND ACCEPTANCE WITH STA. LUCIA REALTY DEVELOPMENT, INC., REPRESENTED BY ITS EXECUTIVE VICE PRESIDENT, MR. VICENTE R. SANTOS, CONSISTING OF TWENTY (20) ROAD LOTS, FIVE (5) ALLEYS AND THREE (3) OPEN SPACES LOCATED AT NORTHWIND SUBDIVISION, BARANGAY NAGKAISANG NAYON, QUEZON CITY.

WHEREAS, the Quezon City Government (QCG) is a public corporation created pursuant to Commonwealth Act No. 502, as amended, and Republic Act No.7160, with principal office at Quezon City Hall, Elliptical Road, Barangay Central, represented by its Local Chief Executive, Honorable Herbert M. Bautista;

WHEREAS, Sta. Lucia Realty Development, Inc. is a domestic corporation duly registered under the laws of the Republic of the Philippines with office address at Sta. Lucia East Grand Mall, Marcos Highway corner Felix Avenue, Cainta Rizal, represented by its Executive Vice President, Mr. Vicente R. Santos;

WHEREAS, the donor is the true and lawful owner of seventeen (17) parcels of land located inside the subdivision known as Northwind Subdivision located at Barangay Nagkaisang Nayon, Quezon City, covered by Transfer Certificates of Title Nos. 15627, 16089, 15704, 17562, 17563, 15870, 16592, 17619, 17921, 17922, 17923, 17924, 17925, 17926, 17927, 17928, and 17929 of the Registry of Deeds of Quezon City;

WHEREAS, in compliance with the provisions of Presidential Decree No. 1216, the donor, hereby donates and conveys in favor of the Quezon City Government, twenty (20) Roads Lots, five (5) Alleys and three (3) Open spaces, found inside the Northwind Subdivision, containing an area of twenty four thousand three hundred twenty two (24,322), three hundred two (302) and four thousand three hundred seventy (4,370) square meters, more or less, respectively;

WHEREAS, the donor hereby transfers, cedes and conveys by way of this Deed of Donation and Acceptance in favor of the Quezon City Government, all the rights, interest and title of the said parcel of land, free from all liens and encumbrances.
