RESOLUTION NO. SP- **6818**, S-2016

A RESOLUTION AUTHORIZING THE QUEZON CITY GOVERNMENT, THROUGH THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO PURCHASE FIVE (5) UNITS OF PROJECTOR WITH WIDE SCREEN TO BE DONATED TO THE FOUR (4) PUBLIC HIGH SCHOOLS IN DISTRICT VI, QUEZON CITY, AND FOR THE USE OF THE OFFICE OF COUNCILOR CANDY A. MEDINA IN THE AMOUNT OF NINE HUNDRED NINETY NINE THOUSAND NINE HUNDRED NINETY FIVE PESOS (PHP999,995.00), CHARGEABLE AGAINST THE FUNDS OF THE SAID OFFICE OF THE CITY COUNCILOR.

WHEREAS, Councilor Candy A. Medina is desiring to procure five (5) units of Projector with Wide Screen, four (4) of which are to be donated to the four (4) public high schools in Quezon City, namely: Culiat High School, New Era High School, Sauyo High School and Tandang Sora High School, all of District VI, and the remaining one (1) is for the use of her office;

WHEREAS, the said projector is beneficial to the city's public high schools students and barangay residents, particularly in the conduct of lectures, seminars, symposia, project and livelihood presentation, educational film showing, and the like;

WHEREAS, under Section 455 (b) (1) (vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the "city mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations; and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance";

WHEREAS, pursuant to the directive of the Department of the Interior and Local Government (DILG), the city government, through the City Mayor, must be given authority by the City Council prior to the procurement of the intended equipment;



NOW, THEREFORE,


