A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO SOUTH AREA AUTOGAS CORPORATION (CLEAN FUEL AUTOGAS) FOR THE CONSTRUCTION AND OPERATION OF A GASOLINE REFILLING STATION AT BALER STREET CORNER MILLER STREET, BARANGAY BUNGAD, QUEZON CITY.




NOW, THEREFORE,


