RESOLUTION NO. SP. 6823, S-2016

A RESOLUTION AUTHORIZING THE QUEZON CITY GOVERNMENT, THROUGH MAYOR HERBERT M. BAUTISTA, TO GRANT FINANCIAL ASSISTANCE IN THE AMOUNT OF SIX MILLION FOUR HUNDRED SEVENTY ONE THOUSAND EIGHT HUNDRED EIGHTY FOUR PESOS AND FOUR CENTAVOS (P6,471,884.04) TO THE MUNICIPALITY OF POLA, PROVINCE OF ORIENTAL MINDORO FOR THE RECONSTRUCTION AND REHABILITATION OF THE MUNICIPAL PUBLIC MARKET, DAY CARE AND ELEMENTARY SCHOOL, AND MULTI-PURPOSE HALL, DESTROYED BY TYPHOON NONA (MELOR), SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS.

WHEREAS, the City Government is empowered under Section 447 (1) (IV) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, to "Adopt measures to protect the inhabitants of the municipality from the harmful effects of manmade or natural disasters and calamities and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events";

WHEREAS, Typhoon "Nona" (International Name: Typhoon Melor) struck the Philippines and one of the most devastated was the Municipality of Pola, Province of Oriental Mindoro with Signal No. 4;

WHEREAS, on December 16, 2015, the Municipality of Pola, passed a Resolution No. 2015-168, Declaring the Municipality of Pola in the Province of Oriental Mindoro under a State of Calamity due to typhoon Nona;

WHEREAS, the Municipality of Pola, Province of Oriental Mindoro also adopted Resolution No. 2016-09, respectfully requesting the Honorable Mayor Herbert Constantine M. Bautista, Quezon City, for financial assistance in the proposed reconstruction and rehabilitation of the Municipal Buildings greatly damaged by typhoon "Nona" on December 15, 2015, to wit;

- a. Pola Old Public Market;
- b. Barangay Buhay na Tubig Day Care Center;
- Barangay Puting Cacao Elementary School;
- d. Barangay Casiligan Elementary School; and
- e. Barangay Misong Multi-Purpose Hall

WHEREAS, the Quezon City Government expressed its sympathy for the victims of Typhoon "Nona", most especially for the Municipality of Pola, Province of Oriental Mindoro;

WHEREAS, the Quezon City Government, through Mayor Herbert M. Bautista, is donating the amount of Six Million Four Hundred Seventy One Thousand Eight Hundred Eighty Four Pesos and Four Centavos (P6,471,884.04) to be taken from the General Fund, as financial assistance specifically for the purpose of the restoration and reconstruction of the Municipal Buildings of the Municipality of Pola, Oriental Mindoro.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize as it does hereby authorize the City Mayor, Honorable Herbert M. Bautista, in behalf of the Quezon City Government, to grant financial assistance in the amount of Six Million Four Hundred Seventy One Thousand Eight Hundred Eighty Four Pesos and Four Centavos (P6,471,884.04) to the Municipality of Pola, Province of Oriental Mindoro for the Reconstruction and Rehabilitation of the Municipal Public Market, Day Care and Elementary School, and Multi-Purpose Hall, destroyed by Typhoon Nona (Melor), subject to Existing Laws, Rules and Regulations.
