A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO ENTER INTO A MEMORANDUM OF WORLD AGREEMENT (MOA) WITH VISION **DEVELOPMENT** FOUNDATION, INC. (WVDF), REPRESENTED BY ITS NATIONAL DIRECTOR, MR. ROMMEL V. FUERTE, FOR THE IMPLEMENTATION OF THE CROWD-BASED MONITORING OF MILK CODE COMPLIANCE IN SUPPORT OF EXECUTIVE ORDER NO. 51, OTHERWISE KNOWN AS "NATIONAL CODE OFMARKETING OF BREASTMILK RELATED SUBSTITUTES, BREASTMILK **SUPPLEMENTS** ANDPRODUCTS" AND REPUBLIC ACT NO. 10028, OTHERWISE KNOWN AS THE "EXPANDED BREASTFEEDING PROMOTION ACT OF 2009", AMENDING FOR THE PURPOSE RESOLUTION NO. SP-7849, S-2019.

WHEREAS, World Vision Development Foundation, Inc. (WVDF), a non-stock, non-profit organization duly organized and existing under the laws of the Republic of the Philippines, is committed to improve the nutritional status of children 0-59 months through its Health and Nutrition Technical Program;

WHEREAS, Executive Order No. 51, otherwise known as the "Milk Code" and Republic Act No. 10028, which is the "Expanded Breastfeeding Promotion Act of 2009" provide mechanisms for the promotion of breastfeeding;

WHEREAS, WVDF and the Local Government of Quezon City will be implementing a two-year project entitled "Crowd-based Monitoring of Milk Code Compliance" (CMMCC), funded by the Bill and Melinda Gates Foundation, a web based project which intends to improve the implementation of Executive Order No. 51, Republic Act No. 10028, and their respective rules and regulations;

WHEREAS, WVDF and the LGU of Quezon City recognize that a collaborative effort among them and other stakeholders in the implementation of the CMMCC Project would redound to the greater benefit of the poor and marginalized children, families and communities.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte to enter into a Memorandum of Agreement (MOA) with World Vision Development Foundation, Inc. (WVDF), represented by its National Director, Mr. Rommel V. Fuerte, for the implementation of the Crowd-Based Monitoring of Milk Code Compliance in support of Executive Order No. 51, otherwise known as the "National Code of Marketing of Breastmilk Substitutes, Breastmilk Supplements and Related Products" and Republic Act No. 10028, otherwise known as the "Expanded Breastfeeding Promotion Act of 2009", amending for the purpose Resolution No. SP-7849, S-2019.
