A RESOLUTION URGING THE CITY HEALTH DEPARTMENT OF QUEZON CITY TO CONDUCT A MASSIVE ANTI-POLIO DRIVE IN EVERY BARANGAY TO PREVENT THE POSSIBLE SPREAD OF POLIOVIRUS.

WHEREAS, unknown to many, polio is a highly contagious disease caused by virus that invades the nervous system, causing fever, fatigue, headache, vomiting, stiff neck, and floppy arms and legs which can be transmitted to other people either by air or due to lack of personal hygiene;

WHEREAS, poliovirus is also dreaded because unvaccinated person, particularly the children ages from zero (0) to five (5), could easily be infected and, if not detected early and remained untreated, would lead to paralysis or result to untimely death;

WHEREAS, for 19 years, the Philippines has been certified poliofree by the World Health Organization (WHO), but recently declared by the Department of Health (DOH) to be beset by a polio outbreak due to reported cases in the provinces of Lanao del Sur, Laguna and Davao and a confirmation of positive test result for poliovirus of some sewerage system and waterways in Tondo, Manila;

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to urge, as it does hereby urge, the City Health Department of Quezon City to conduct a massive antipolio drive in every barangay to prevent the possible spread of poliovirus.

RESOLVED, FURTHER, that a copy of this Resolution be forwarded to the City Health Department of Quezon City for their information and appropriate action.
