WHEREAS, the Scholarship and Youth Development Program seeks to ease the current manual releasing of such stipends and allowances to the City Scholars;

WHEREAS, this initiative will be beneficial and advantageous to the Quezon City Scholars as they can go to the nearest ATM in order for them to withdraw their allowances;

WHEREAS, the Office of the City Mayor, through the Scholarship and Youth Development Program, would like to partner with PayMaya in this endeavor;

WHEREAS, there are already five (5) local government units (LGUs) that have partnered with PayMaya for this endeavor for the disbursement of allowances of their scholars also;

WHEREAS, pursuant to Section 455 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991", the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to law or ordinance;

WHEREAS, the subject Disbursement Service Agreement and the Confidentiality and Non-Disclosure Agreement shall become effective upon the ratification of the Quezon City Council.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to enter and sign the Disbursement Service Agreement and Confidentiality and Non-Disclosure Agreement with PayMaya Philippines Inc. for the automation of City Scholars' Stipend/Allowances Disbursement.
