WHEREAS, the Local Ordinance would give premium in helping Solo Parents improve their income;

WHEREAS, the Labor Department, meanwhile would extend their employment by equipping them with additional support which includes TUPAD program for at least once or twice a year to all qualified Solo Parents within the city who live below the poverty threshold;


WHEREAS, there is a need to provide additional benefits such as this to address rising economic cost of living standards, especially their situation as Solo Parents.
