WHEREAS, the Health Facilities Enhancement Program (HFEP) aims to improve the delivery of health services through the upgrading of the health facilities and provision of medical equipment in order to make more responsive to the health needs of the inhabitants;

WHEREAS, the Department of Health donated one (1) unit of Ambulance to each of the above-mentioned health centers, including the equipment therein amounting to Two Million Eighty-Eight Thousand Pesos (Php2,088,000.00) per unit;

 - Manual Resuscitators for infant
 - Oxygen Cylinder 20-liter capacity and with oxygen regulator with humidifier
- Communication Experiment
 - Two (2) pieces cellular phones
