WHEREAS, the Lupong Tagapamayapa is an administrative body created under the Local Government Code of 1991 to operationalize the barangay justice system known as the Katarungang Pambarangay which facilitates amicable settlement of disputes such as alarm and scandal, less serious physical injuries, slight physical injuries and maltreatment, simple seduction, and issuing checks without sufficient funds, removal, sale or pledge of mortgaged property, and qualified trespass to dwelling;


