RESOLUTION NO. SP- **8076** , S-2020

**A RESOLUTION GRANTING A SPECIAL PERMIT TO MANILA COCKERS CLUB, INC. TO OPERATE AN OFF-COCKPIT BETTING STATIONS IN FIFTY-SIX (56) LOCATIONS WITHIN THE TERRITORIAL JURISDICTION OF QUEZON CITY.**

*WHEREAS, Manila Cockers Club, Inc. is a domestic corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with office address at 14<sup>th</sup> Floor, Strata 100 Building, F. Ortigas Jr. Road, Ortigas Center, Pasig City;*

*WHEREAS, Manila Cockers Club, Inc. is primarily engaged in the business of cockfighting which include, but not limited to, the construction, establishment, and operation of cockpits, the conduct and broadcast of cockfights, and the accepting of bets thereon through conventional and electronic means;*

*WHEREAS, to enable the applicant to operate Off-Cockpit Betting Stations in Quezon City, there is a need to secure a Special Permit from the City Council pursuant to Ordinance No. SP-2285, S-2014, in relation to the provisions of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;*


