WHEREAS, due to industrial, commercial and residential development, coupled by undisciplined garbage disposal and illegal settlement in waterways, some parts of Quezon City are now easily inundated every time there is a monsoon rain or heavy downpour;

WHEREAS, as a consequence of flooding, heavy traffic congestion always occur, school classes suspended, floodwater-related diseases spread. Also, most of the infrastructure projects, public and private establishments, and dwellings were damaged, and innocent lives were lost:

WHEREAS, to prevent or contain the perennial flooding in Quezon City, there is an imperative need for the city government to invest in waterways infrastructure for the repair, improvement or reconstruction of drainage system, rip-rapping of creeks, rivers and other waterways, and the like.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to urge, as it does hereby urge, the City Mayor, Honorable Ma. Josefina G. Belmonte, to include in her priority projects the investment in waterways infrastructure to prevent or contain the perennial flooding in Quezon City.
