A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO IMPLEMENT THE FIRST TRANCHE OF THE MODIFIED SALARY SCHEDULE IN THE LOCAL GOVERNMENT OF QUEZON CITY PURSUANT TO THE PROVISIONS OF REPUBLIC ACT NO. 11466, IN RELATION TO DBM LOCAL BUDGET CIRCULAR NO. 121 DATED JANUARY 24, 2020.

WHEREAS, on January 8, 2020 Republic Act No. 11466, otherwise known as the Sulary Standardization Law of 2019, was approved by President Rodrigo Roa Duterte to provide all government personnel a just and equitable compensation in accordance with the principle of equal pay for work of equal value;

WHEREAS, to promote social justice and to make the compensation of the Quezon City Government personnel competitive with those in the private sector, there is a need to standardize the same in order to attract, retain and motivate a corps or competent and dedicated civil servants;

WHEREAS, the Department of Budget and Management (DBM) issued Local Budget Circular No. 121 dated January 24, 2020, for the purpose of prescribing guidelines, rules and regulations for the implementation of the first tranche effective not later than January 1, 2020 of the modified salary schedule for civilian personnel and the grant of additional benefits stipulated in Republic Act No. 11466;

WHEREAS, the amount of One Hundred Eighty-Three Million Eighty-Eight Thousand One Hundred Twenty-Six Pesos (Php183,088,126.00) needed for its implementation has already been appropriated in the 2020 Annual Budget of Quezon City;

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to implement the First Tranche of the Modified Salary Schedule in the Local Government of Quezon City pursuant to the provisions of Republic Act No. 11466, in relation to DBM Local Budget Circular No. 121 dated January 24, 2020.

RESOLVEL) FURTHER, that the funding requirement for the implementation of the subject Modified Salary Schedule shall be taken from the 2020 Annual Budget of Quezon City under Other Personnel Benefits of the Office of the City Mayor.

RESOLVEL FINALLY, that the effectivity of the implementation of the First Tranche of Modified Salary Schedule shall not be earlier than January 1, 2020.
