RESOLUTION NO. SP- **8181**, S-2020

A RESOLUTION GRANTING THE RENEWAL OF THE SPECIAL PERMIT TO B-7 AMUSEMENTS CORPORATION TO OPERATE AN ELECTRONIC BINGO GAMES AND E-GAMES LOCATED AT CIRCLE C MALL, CONGRESSIONAL AVENUE, BARANGAY BAHAY TORO, QUEZON CITY, SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR).

WHEREAS, B-7 Amusement Corporation is a domestic corporation duly organized and existing under and by virtue of Philippine laws, represented by Engr. Manuel M. Delos Santos, Jr., is applying for a Special Permit to operate Electronic Bingo Games and E-Games at Circle C Mall, Congressional Avenue, Barangay Bahay Toro, Quezon City;

WHEREAS, the applicant was previously granted a Special Permit by the City Council for the operation of the same business;

WHEREAS, to enable the applicant to continue its business operations, there is a need to renew their Special Permit by the City Council for the operation of the said business;


WHEREAS, Republic Act No. 7160, otherwise known as the Local Government Code of 1991, in relation to existing city ordinances, authorizes the City Council to grant or renew a special permit to business activity of the same nature.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant, the renewal of Special Permit to B-7 Amusement Corporation to operate Electronic Bingo Games and E-Games located at Circle C Mall, Congressional Avenue, Barangay Bahay Toro, Quezon City, subject to the Rules and Regulations promulgated by the Philippine Amusement and Gaming Corporation (PAGCOR).

RESOLVED FURTHER, that the authority to operate Electronic Bingo Games and E-Games granted herein shall be subject to the following conditions:

- a. The holding of Electronic Bingo Games and E-Games shall be in accordance with the rules and regulations promulgated by PAGCOR;*
- b. The operation of Electronic Bingo Games and E-Games shall not include the playing of games not related to or other than Electronic Bingo Games and E-Games;*
- c. The operator is enjoined to prohibit individuals below eighteen (18) years of age from playing in the above-mentioned games.*


