RESOLUTION NO. SP-8182, S-2020

A RESOLUTION GRANTING THE RENEWAL OF SPECIAL PERMIT TO I-CYBERWORLD BIZ, INCORPORATED TO OPERATE AN ELECTRONIC GAMING LOCATED AT THE 2<sup>ND</sup> FLOOR, INTREPID PLAZA, E. RODRIGUEZ JR. AVENUE, BARANGAY BAGUMBAYAN, QUEZON CITY, SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR).

WHEREAS, I-Cyberworld Biz, Incorporated is a domestic corporation duly organized and existing under and by virtue of Philippine laws, represented by Ms. Heidi DC. Payumo, is applying for a Special Permit to operate an Electronic Gaming located at the 2<sup>nd</sup> Floor, Intrepid Plaza, E. Rodriguez Jr. Avenue, Barangay Bagumbayan, Quezon City;

WHEREAS, to enable the applicant to continue its business operations, there is a need to renew their Special Permit by the City Council for the operation of the same business;

WHEREAS, Republic Act No. 7160, otherwise known as the Local Government Code of 1991, in relation to existing city ordinances, authorizes the City Council to grant or renew a special permit to business activity of the same nature.

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant, the renewal of the Special Permit to I-Cyberworld Biz, Incorporated to operate an Electronic Gaming located at the 2<sup>nd</sup> Floor, Intrepid Plaza, E. Rodriguez Jr. Avenue, Barangay Bagumbayan, Quezon City, subject to the Rules and Regulations promulgated by the Philippine Amusement and Gaming Corporation (PAGCOR).

RESOLVED FURTHER, that the authority to operate an Electronic Gaming granted herein shall be subject to the following conditions:

- a. The holding of Electronic Gaming shall be in accordance with the Rules and Regulations promulgated by PAGCOR;
- b. The operation of Electronic Gaming shall not include the playing of games not related to or other than Electronic Gaming;
- c. The operator is enjoined to prohibit individuals below eighteen (18) years of age from playing in the abovementioned games.

RESOLVED FINALLY, that this renewal of Special Permit to operate Electronic Gaming shall be valid for a period of two (2) years from the approval of this Resolution and may be renewed again by the City Council.
