WHEREAS, the contracts for solid waste collection, cleaning and disposal 2020-2021 project was signed and entered into by City Mayor Ma. Josefina G. Belmonte on April 28, 2020;

WHEREAS, garbage collection and disposal continues to be a perennial problem not only in Quezon City, but in the entire country as a whole;

WHEREAS, the city is expressly mandated by the Local Government Code of 1991 to deliver basic services related to general hygiene and sanitation to its residents.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to ratify, as it does hereby ratify, the contract entered into by the City, as represented by the City Mayor, Honorable Ma. Josefina G. Belmonte, with the winning bidders for the solid waste cleaning, collection and disposal 2020-2021 project, under the terms and conditions laid down by the pertinent contracts, ordinances and laws, as far as practicable and applicable, the Contract of Service with the following Service Providers:
