A RESOLUTION URGING ALL BUSINESS ESTABLISHMENTS OPERATING IN QUEZON CITY TO PRACTICE RECYCLING OF WATER FOR NON-POTABLE USE, IMPLEMENT RESPONSIBLE WATER USE AND WATER CONSERVATION MEASURES AND INSTALL RAINWATER HARVESTING SYSTEMS.

WHEREAS, since the first quarter of 2019, Angat Dam, Ipo Dam, and La Mesa Dam registered low water levels which has resulted in scheduled water interruptions that affected numerous households, schools, hospitals, and businesses, among others;

WHEREAS, to help ease the burden on the consumers, water concessionaires had water rationing services available in different barangays in the City until the water supply has normalized;

WHEREAS, with the re-issuance of a water interruption schedule during the last quarter of this year and the possible reduction of water supply in the coming months especially during the summer, there is now a need to collectively address the problem through strategies that will sustainably promote responsible use of water in all sectors of the City;

WHEREAS, one of the sectors that need to take action is the business sector since water is a crucial resource in their daily operations from production to manufacturing of a product or service.

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to urge, as it does hereby urge, all business establishments operating in Quezon City to practice recycling of water for non-potable use, implement responsible water use and water conservation measures and install rainwater harvesting systems.
