A RESOLUTION AUTHORIZING THE CITY MAYOR, TO ENTER INTO A NEGOTIATED CONTRACT TO ACQUIRE A PARCEL OF LAND LOCATED AT NO. 61 DURIAN STREET, BARANGAY QUIRINO 2-C FOR THE CONSTRUCTION AND ESTABLISHMENT OF A NEW BARANGAY HALL FOR BARANGAY QUIRINO 2-C AND PROVIDING APPROPRIATION THEREOF.

WHEREAS, the incumbent Barangay Officials of Quirino 2-C, through a letter, made representation before the City Mayor, Honorable Ma. Josefina G. Belmonte, for the need to acquire a parcel of land and the construction of the barangay hall;

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, to enter into a negotiated contract to acquire a parcel of land located at No. 61 Durian Street, Barangay Quirino 2-C for the construction and establishment of a new Barangay Hall for Barangay Quirino 2-C and providing appropriation thereof.
